The Ministry of the Environment, Conservation and Parks (MECP) had attained the services of McIntosh Perry Consulting Engineers to review the following geotechnical reports which was submitted in accordance with Condition R of Renewable Energy Approval (REA) No. 0871-AV3TFM, issued on May 4, 2018:

- *"Wind Turbine Generator Foundations" report, revised for permit January 8, 2019;*
- *"Overhead and Underground Collection System" report, issued for use January 18, 2019;*
- *"Substation" report, issued for use December 11, 2018;*
- *"Pre-Construction Road Condition Survey Data" report, submitted January 18, 2019 and*
- *"MET Tower" report, issued for permit January 22, 2019*



As a result, EDP Renewables Canada Ltd. submitted revised versions of the Wind Turbine Generator report and the Overhead and Underground Collection System report for further review and comment.

On May 10, 2019, McIntosh Perry Consulting Engineers provided the enclosed memorandum with confirmation that all comments were addressed by EDP Renewables Canada Ltd. and there are no further comments and/or recommendations.
