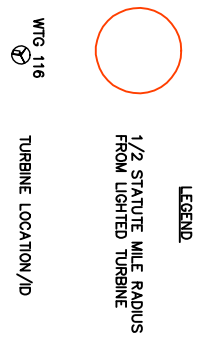
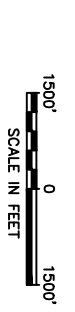
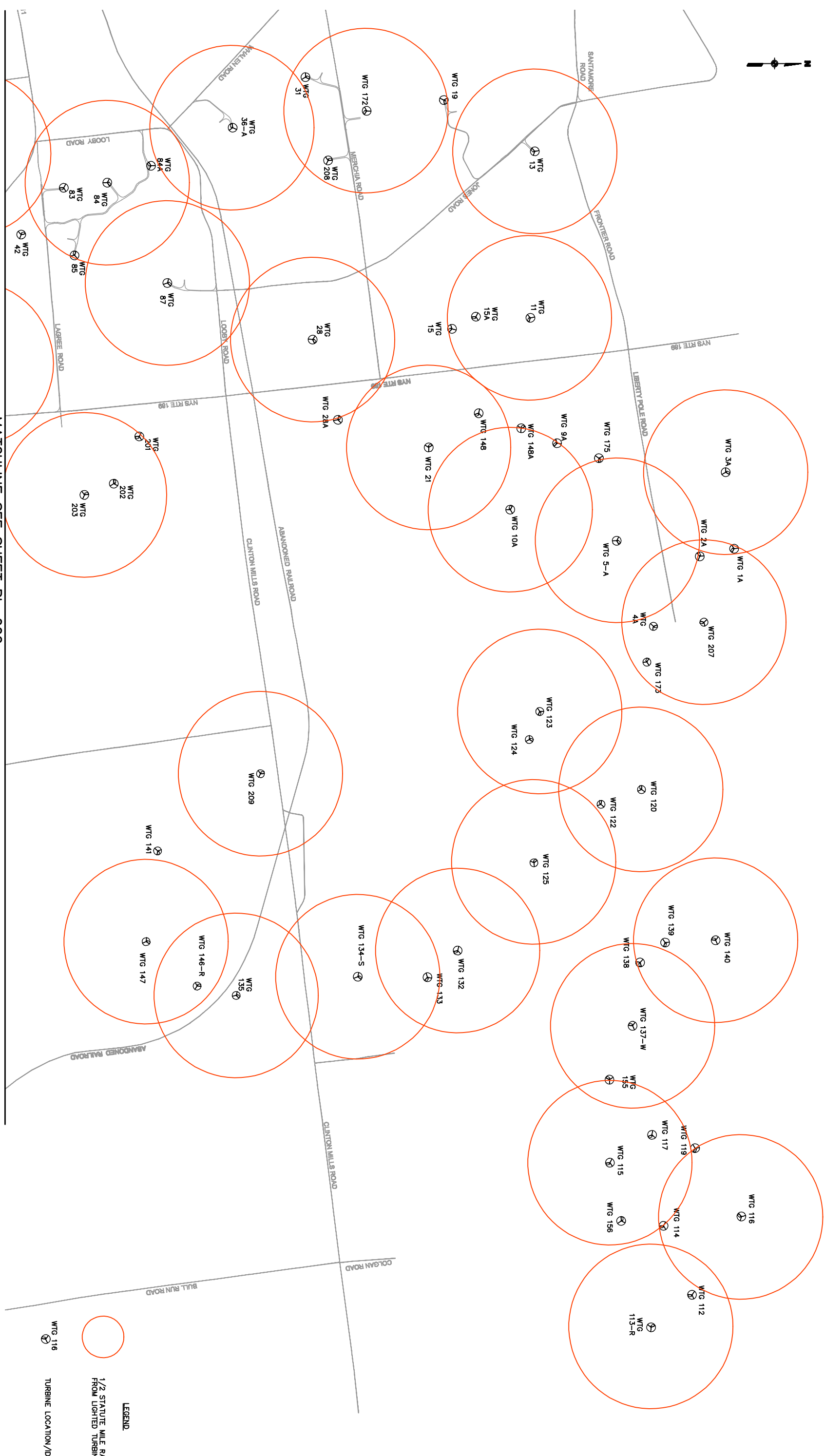
Proposed Lighting Plan Marble River Wind Farm

June 22, 2007

The proposed lighting plan for Marble River Wind Farm was developed by Marble River, LLC based on guidelines in the U.S. Department of Transportation Federal Aviation Administration Advisory Circular AC 70/7460-1K "Obstruction Marking and Lighting" effective February 1, 2007.

The lighting plan calls for lighting 43 of 109 proposed wind turbine generators (WTG's). Table 1 identifies the coordinates and elevations for each WTG and identifies which WTG's will be lighted. Figure 1 shows red circles of ½ statute mile radius centered on each lighted WTG.

Marble River, LLC will submit a Notice of Proposed Construction or Alteration (FAA Form 7460-1) for each proposed WTG and the Lighting Plan will be finalized based on requirements determined by the FAA's Obstruction Evaluation Service.

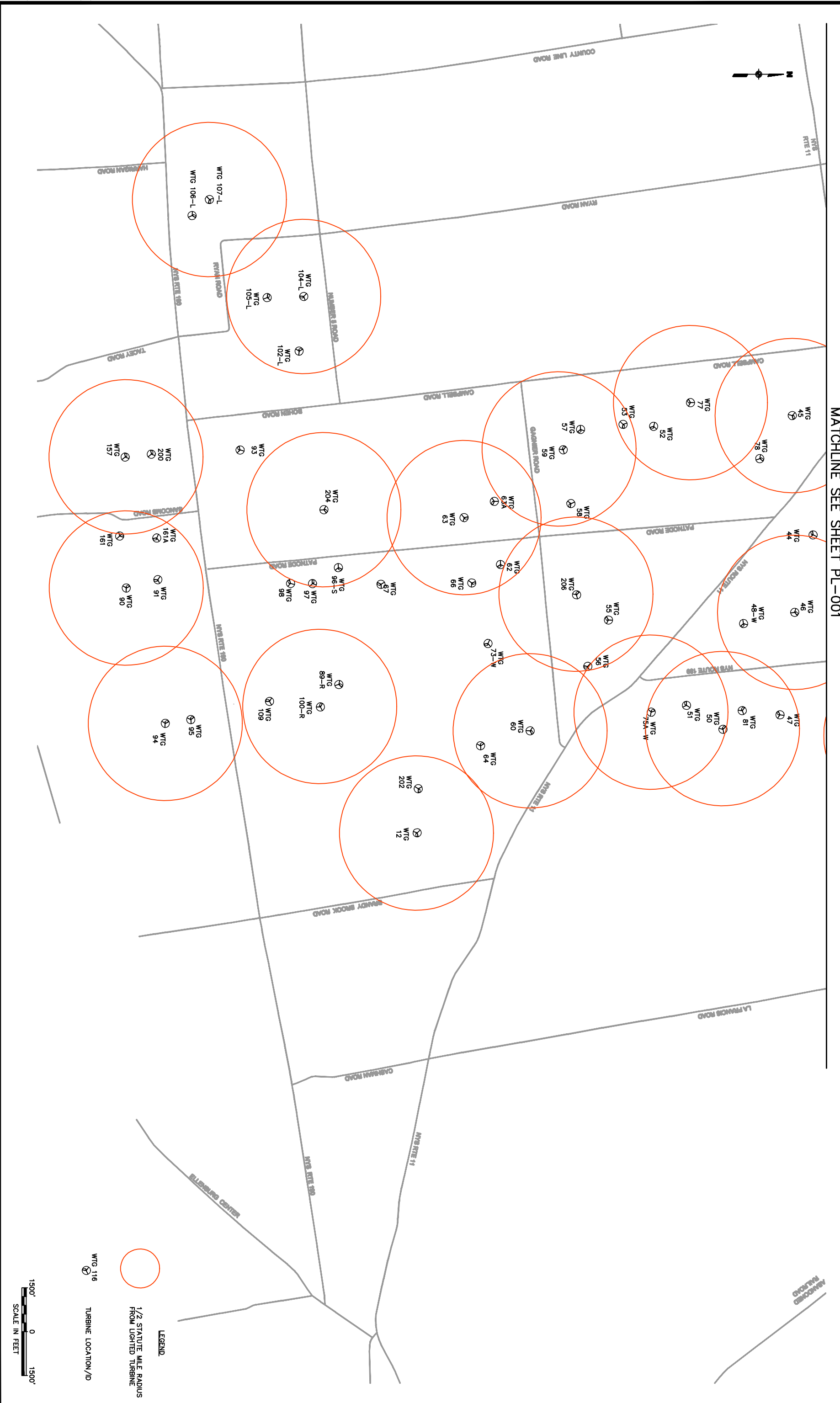
