EDPR signs Asset Rotation deal for a 191 MW renewables portfolio in Italy

Madrid, June 29th 2024: EDP Renováveis, S.A. ("EDPR") signed a Sale and Purchase Agreement with PLT Rew 2 S.r.l., an industrial Italian player and a subsidiary of PLT Energia, to sell a 100% equity stake of a 191 MW wind portfolio in Italy for an estimated Enterprise Value of €0.4 billion.

The transaction scope comprises 7 operating wind farms located in the south of Italy in operation for an average of 1.4 years, 5 projects benefit from a regulated tariff ("CfD") and 2 from a PPA.

The deal is subject to customary precedent conditions.

This Asset Rotation comes in the context of the ~€6 billion program for 2024-26 presented in May 2024 Business Plan Update, allowing EDPR to accelerate value creation while recycling capital to reinvest in accretive growth.
